No part of the work carried out in fulfillment of the programme will be utilized commercially or applying for a patent without the approval of Indian Institute of Technology Madras and on terms mutually agreed by IIT Madras and this organization.

We have also noted that the following conditions to be satisfied for sponsoring of candidates for M.Tech. programme :

1. The candidate has **first class** with a minimum of **60% aggregate Marks** (55% in case of SC/ST) (over the four years) in the Bachelor's degree in Engineering or equivalent (First class Master's Degree holders in Physics / Mathematics / Statistics / Computer Science are also eligible to apply for M.Tech. in Computer Science and M.Tech. in Industrial Maths and Scientific Computing).
2. Those possessing Associate Membership such as AMIE will be considered for their parent discipline and have passed **both Part A and Part B with 60%** of aggregate marks.
3. The candidate has a minimum professional experience of two years as on **30-4-2024** excluding training period in this organization.
4. **The deputed staff has to be given full pay and allowances for 24 months during his / her study at IIT Madras.**
